Full Insurance Coverage Required on Vehicle Loans

If you have a vehicle loan with APGFCU, you are required to maintain comprehensive and collision coverage for the entire term of the loan. The deductible should not exceed \$1,000 for cars, motorcycles, and jet skis, and it should not exceed 3% of the unit's value for boats and RVs.

If you do not maintain the required insurance throughout the life of the loan, APGFCU may purchase a policy to protect the collateral and pass the cost of the policy to the borrower. These premiums will be added to the loan balance, resulting in an increase to the monthly payment to cover the additional cost. Policies purchased by APGFCU only protect the vehicle and do NOT include liability coverage, which is required by the state of Maryland. This means if the borrower is in an accident, the collateral insurance APGFCU secures on the vehicle will only cover the vehicle and NOT cover any damages caused by you to others.
